2. Registration Fee of R396.00 will be paid on registration of your team.
3. All teams will play a minimum of four 22:00 games. (Excluding re fixtures)
4. Game changes will only be considered in extreme circumstances (require one weeks notice)
5. All league games must be played in order to qualify for finals.
6. Management has sole discretion to move a team within leagues.
7. Any team that forfeits a game or cancels a game within 48 hours is liable for the cost of the court R792.00 and must pay in full before the next league game.
8. Teams withdrawing form the league will be liable for R1500-00 withdrawal fee.
9. Please supply our admin staff with any preferences regarding fixtures and we will try our best to accommodate you.
